

1. GENERAL DESCRIPTION OF THE CCB MOBILE SERVICE

1.1. Operating systems

The application for mobile banking CCB Mobile can be downloaded free of charge via App Store, Google Play or Huawei AppGallery and be used on the following operating systems and mobile devices:

- 1.1.1.Operating systems: iOS 11.0 +, Android 6.0 +;
- 1.1.2.Devices: all iPhone and iPad mobile devices with iOS version 11.0 or higher and all mobile devices with Android operating system version 6.0 or higher;

It is necessary to have access to the Internet via Wi-Fi or mobile Internet. To use CCB Mobile with mobile Internet from your mobile operator, check your individual tariff plan.

1.2. Possibilities of the system for Mobile banking

Via CCB Mobile you can:

- Perform BGN and currency transfers in the country and abroad between own accounts, to arbitrary beneficiaries and counterparties;
- Perform express interbank payments in BGN via RINGS;
- Confirm mass files, which are entered via CCB Online with QES;
- Confirm transfers, which are entered via CCB Online with QES;
- Make transfers to the budget;
- You perform activities related to the management of bank cards;
- You receive reference information of operations, performed with bank cards;
- Make reports for the last movements and statements for a period on the account;
- Perform FX purchase and sale;
- Pay utility bills;
- Make payment with QR or 10-digit code;
- Negotiate exchange rates upon the performance of transfers and FX purchase and sale;
- Receive reference information and statements for all accounts, opened with CCB Plc;
- Receive reference information about the state of the credit liabilities of individuals;
- Perform repayment of liabilities related to consumer loans and credit cards;
- Confirm online card transactions with biometric authentication.

You may use the CCB Mobile service at more than one mobile device.

1.3. Limits

The limits for the performance of transfers in CCB Mobile are as follows:

- Daily limit for all operations, performed via the service CCB Mobile, is in the amount of the BGN equivalent of EUR **15'000** (fifteen thousand euro) (BGN 29'337.45 at the BNB reference rate).
- Maximum limit for transfers to counterparties, payment of utility bills and payments to the budget **BGN 20`000.00** for 24 hours.
- Maximum limit for transfers to arbitrary beneficiaries **BGN 8`000.00** for 24 hours.



1.4. Users

The CCB Mobile service can be used by individuals and legal entities, clients of CCB Plc, on whose name and at whose expense the activities are performed in the system for Mobile banking of CCB Plc, as follows:

Individuals, who have a personal qualified electronic signature /QES/;

Individuals, who do not have a personal qualified electronic signature /QES/;

Legal entities, via their legal representatives and/or authorized individuals, who have a personal qualified electronic signature /QES/;

Legal entities, via their legal representatives and/or authorized individuals, who do not have a personal qualified electronic signature /QES/;

"User" is every individual, registered in the system for Mobile banking of CCB Plc with rights determined by the beneficiary, specified in the application for registration /change for the performance of bank operations. User can be an individual, with the respective rights of beneficiary – a legal representative or an authorized person with rights to dispose.

The legal entities can use the service CCB Mobile with users of the type:

- Legal representative
- Beneficiary
- Authorized with the right to dispose

1.5. Recommendations and security measures

The security of the system for mobile banking is ensured via a number of measures, impacting each level of the service:

- There is an encryption of the information, which is submitted from the application of the mobile phone to the Bank servers via using https (ssl) protocol.
- The identification of the user is carried out via a combination of the registered device, bound by the user name, password and a personal user PIN.
- Temporary locking of the device for one hour upon the entry of three wrong PINs.
- Deactivation of the device upon the entry of six wrong PINs.
- The authorization at transaction level is carried out for each transaction via built in encryption methods, which ensure the highest level of security, against external and internal threats.
- The system infrastructure uses hardware security mechanisms (HSM), which guarantee the security of the performed encryption calculations.
- The is an array of possibilities to specify rights, limits and management of the system
- for mobile banking via the system for Internet banking.
- The recommendations for security of programming and the creation of mobile applications are taken into consideration in the creation of the mobile application. The applications passed tests and verification of the code from Apple for iOS devices, and respectively from Google for Android devices.
- CCB Plc does not send an e-mail, which contains Internet Link /link/, leading to a

page, on which you have to enter the user name and password, update your profile or an enclosed file, which you have to install.

- The obligations and responsibilities of the client /user in relation to the security of the mobile banking service are as follows:
- To protect his/her user PIN from unauthorized access, not announcing it, keep it at secure places not accessible for third persons.
- To keep physically the devices, on which the application for mobile banking of the Bank was installed.
- To use the standard mechanisms for security of the operating system of the mobile devices, such as access code, which should not coincide with the chosen PIN for access to the mobile application.
- To keep the user name, password and PIN for QES (qualified electronic signature), which are necessary for access to the system for Internet Banking, via which the mobile banking service can be managed.
- To ensure the security of the operating system of the mobile device, via installing its latest updates. Not to use "jailbroken" and "rooted" devices, where the mechanisms for the security of the operating system have been destroyed.
- It is recommended to use an anti-virus program for protection from viruses, and it is not recommended to use suspicious mobile applications, which can undermine the security of the mobile application.
- In case of a loss or theft the user shall deactivate the device in the system for Internet banking, or if this is not possible to contact the Centre for servicing clients at 02/92 66 500 or visit an office of the Bank.
- To protect the mobile device with a password and specifying automatic locking of the screen, when it is not used.
- To install antivirus software on the smart phone and regularly update the smart phone software.
- To download applications only from official application sites App Store, Google Play or Huawei App Gallery.
- To use the "EXIT" button upon exiting the system.
- To disable the function "Remembering passwords in the browser".
- In order not to expose your device to risk, we recommend to you not to use chance wireless Internet connections.

Upon non-performance of the above mentioned security obligations, including, but not limited to, in relation to using and protection of the PIN or the six digit code for registration, CCB Plc does not bear responsibility for damages suffered by the client /or user or by third persons, upon using the mobile banking service.

CCB Plc does not bear any responsibility for any damages suffered by the client /user or by third persons and in case of an interference of malicious software on the mobile device, with which the application is accessed or for intentional actions of third persons.

1.6. Fees and commissions

- For using bank services and the performance of bank operations via the system for Mobile banking of CCB Plc, the client shall pay fees and commissions, in accordance with the effective Tariff on the interest rates, fees and commissions, and its appendices.
- The Bank is entitled to change its Tariff at any time, informing the clients in accordance with the procedure laid down in the General terms and conditions to the frame agreement for the opening and maintenance of bank payment accounts and the performance of payment operations or in the specific contract for a bank service, concluded between the Bank and the client.

2. REGISTRATION AND CONFIGURATION OF A PROFILE FOR MOBILE BANKING

2.1. Registration of new clients – two applications are submitted – one for registration for the service and one for registration of the mobile device.

If you do not have an active registration for Internet banking CCB Online and/or CCB Lite it is necessary to:

- 1. Download the application via App Store, Google Play or Huawei AppGallery depending on the operating system iOS or Android.
- 2. Submit an application for the registration for the service CCB Mobile in one of the following ways:
- On the web site of Central Cooperative Bank Plc at:_ www.ccbank.bg.

Select on the banner - , after that on the Registration button and "Press here to make your registration for CCB Online".

You should select the type of registration, which you submit – legal entity or individual. For **individuals** you should select "Registration for CCB Lite / CCB Mobile".

For legal entities you should select "Initial registration of a company for CCB Mobile"





or "Addition of a company user for CCB Mobile".

After successful submission of the application for registration you will receive a code for registration at the email specified in the application, with which you should visit an office of the Bank for confirmation of the registration.

The employee in the Bank office will confirm the application for registration for the service CCB Mobile created by you, will configure your desired rights and limits.

For this purpose it is necessary to sign an "Application for *specifying/change of rights and limits for the services of CCB Plc" and a contract for using the service CCB Mobile"*. The legal entities shall submit the application at the servicing branch, unless they use the service CIMS. Request and contract can be signed by an authorized person upon providing a notarized power of attorney.

- 3. Submit an application for the registration of the mobile device in the application installed in the memory of the device select **"Add user"** and enter the username and password to access CCB Mobile.
- 4. Visit an office of the Bank for confirmation of the device and receipt of a six-digit PIN.
- At any office of the Bank you can receive a sealed envelope, containing the username and password for access.

2.2. Registration of clients, using CCB Online and/or CCB Lite, for CCB Mobile

If you have active Internet banking CCB Online and/or CCB Lite it is necessary to:

1. Download the application via App Store, Google Play or Huawei App Gallery depending on the operating system iOS or Android.

After installation in the memory of the mobile device, enter the application and select **"Add user"** from the initial screen. The application redirects to the site of the Bank, where it is necessary to enter a username and password for access to the active service CCB Online or CCB Lite.

2. Submitted application for the registration of the device is confirmed by entering a 6-digit code in the application, which you may receive via the system for Internet banking CCB Online or at an office of the Bank:

- at an office of the Bank the registration of the device for CCB Mobile will be confirmed at an office of the Bank, where an employee will confirm the service, will configure the desired rights and limits and will provide you with a code for access in the application. It is necessary to enter in the application the provided code for registration of the device. After that the system will require to enter and confirm a six-digit PIN, which will serve for logging into the application and for confirmation of transfers and other operations performed via the application.
- in the Internet banking CCB Online the application for confirmation of the device will visualize in the menu "Applications for registration of devices" on initial screen.

The system will generate a six digit code, which you should enter in the mobile application. Select the button "Continue" and a message will appear on the screen that it is necessary to visit an office of the Bank, in order to activate the registration for the service CCB Mobile.

You enter in the application the generated code for registration of the device. The system will request from you to enter and confirm the six-digit PIN, which serves for entry in the application and for confirmation of transfers and other operations, effected via the application.

3. You should visit an office of the Bank, where an employee will activate the service CCB Mobile and will configure your desired rights and limits to work in the system for Mobile banking. For this purpose it is necessary to sign "An application for specification /change of rights and limits for the services of CCB Plc" and a Contract for using the service CCB Mobile". The legal entities shall submit the application in the servicing branch, unless they use the service CIMS.

Request and contract can be signed by an authorized person upon providing a notarized power of attorney.

Before activating the service CCB Mobile, the message "Expecting confirmation" will appear in the application.

2.3. Configuration and setup of a profile

You can make changes in the registration in one of the following ways:

- via visiting an office of the Bank and declare this in writing;
- via *CCB Online* with SMS received at the number of a Bulgarian valid mobile operator provided by you, in case you declared in the application an activation of the option "Confirming changes only with SMS".

Via the menu "SETTINGS" -> "Changes of registrations /Limits" at CCB Online you can make the following changes:


- Change of account status- active for payment, only for reference or deletion
- Change of limits
- Addition, change or deactivation of transfer counterparties
- Cards, which are seen in the mobile banking
- Activation, deactivation and temporary restricting the devices

All changes, effected via the menu "Changes in registrations /Limits" are confirmed with SMS code and password.

2.4. Log into the application

After the activation of the access to the mobile device is completed at an office of the Bank, in order to use CCB Mobile, it is necessary to create PIN to access the application. The code serves for identification upon each entry in the application, upon confirming each transfer, effected via the registered device. The PIN should be 6-digit and it is desired and recommended to change it often and not to contain personal data – birthday, personal number, etc. Upon first entry in the application the PIN code is entered twice – creation and confirmation. After the successful log into the application, a screen appears with the general view of CCB Mobile.



NOTE: Upon the entry of three wrong PINs the access to the device will lock temporarily for one hour.

Upon the entry of six wrong PINs the device will be deactivated. You can activate the device at an office of the Bank or via CCB Online with QES, submitting in advance an application for the registration of the device from the initial screen of the application from the menu **"Add user"** via the entry of a username and password.

3. ACCOUNTS

3.1. General overview

The "Accounts" menu gives information of the accounts, which are added to the registration in CCB Mobile.


NOTE: Each newly opened account of a client – individual is added automatically in CCB Mobile as active.

In case you do not want to see an account in the application it is necessary to visit an office of the Bank or remove it via CCB Online with QES.

NOTE: To add a newly opened account of a client – legal entity it is necessary to visit a bank office. The account is not added automatically.

A list is visualized, in which you see the names of the clients and the accounts opened on their behalf. The general view gives the following information about each of the accounts:



- Account beneficiary
- Account type
- IBAN
- Availability
- Currency



3.2. Detailed information for each account

Upon selecting an account via touching the screen, a detailed report is visualized for the account, which depending on the account type, includes:

- Name of account
- IBAN is copied from Button
- Type of account
- Currency
- Disponible amount the amount, with which operations may be performed
- Available amount the entire account balance
- Allowed overdraft visualized only for checking account, if there is overdraft granted on the account
- Interest rate– visualized only for deposit accounts
- Opening date visualized only for deposit accounts
- Maturity date visualized only for deposit

3.3. Recent movements

Deactivation

Via button "Recent movements" information is loaded of the disposable amount, availability, origin and debits of the last movements on the selected account.

3.4. Account statements for a period

A statement of the selected account is generated via the selection of the button "Account statements for a period" and specifying the initial and end date of the desired period. The statement presents information of the availability on the account as at the initial and end date, credits and debits on the account in the chosen period. The extract can be downloaded as a PDF file – the button is located in the upper right corner.

When a button is pressed, the data from the specific field is copied. The extract can be downloaded as a PDF file - the button is located in the upper right corner, and then shared and/or printed.

3.5. Blocked amount

With the "Blocked amount" button you can get information about the blocked amount on the selected account (blocked amount at the request of the account holder, imposed distraint or

collateral on the account). In case there is no blocked amount on the account, the message "There is no blocked amount on the account" is displayed.

3.6. Change alias

Menu "Change alias" provides a possibility to change the identification of the selected account.

3.7. Deactivation

From "Deactivation" menu you can deactivate your desired account. Upon deactivation, the account continues to be visualized, account reports may be generated, but transfers cannot be effected via the application.

In case you want an account to be active again for operations via CCB Mobile, it is necessary to visit an office of the Bank.

Individuals, users of the service Internet banking CCB Online, who have activated the option "Confirming changes only with SMS", will be able again to activate the accounts in their profile, without visiting an office of the Bank.

3.8. Remove

From menu "Remove" you can delete the selected account. Upon deletion the account will not be visualized in the application, it will not be possible to make transfer from the account and generate account statements via the application.

4. TRANSFERS

From "Transfer" menu you can effect:

- Transfer to an own account
- Transfer within the Bank
- Transfer to another bank
- Transfer to the budget
- Currency transfer to another bank

The menu provides access to information regarding:

- Transfers, awaiting confirmation
- Transfers, awaiting processing in the Bank
- Outgoing transfers history
- Templates
- Counterparties

Every transfer ordered via CCB Mobile is confirmed via the entry of a PIN or Face ID/Touch ID (Fingerprint).





- **IMPORTANT!** The system allows the creation of payment orders, from an account with insufficient availability, with a current and future execution date.
- When attempting to confirm a transfer made from an account with insufficient availability and with a current execution date, the system does not allow the operation to be carried out.
- Future date transfers can be entered and confirmed as the system does not check for availability at the time the transfer is confirmed.

4.1. Transfer to an own account

From this menu you can enter transfers to own accounts.

In order to create a transfer to an own account, it is necessary to enter the following components:

Ordering customer

You select Ordering customer via button **E**, from which all accounts of the Ordering customer and of his represented persons are visualized. Via selecting an entry, the name and IBAN of the Ordering customer are loaded in the respective fields.

Amount

Enter the transfer amount.

Beneficiary

You select Beneficiary via button **E**, from which all accounts of the user and the accounts of the persons represented by him/her are visualized. Via selecting an entry, the name and IBAN of the Beneficiary are loaded in the respective fields.

Transfer details

The field for remittance information is obligatory for completion (up to 140 characters).

Date

The date of transfer performance by default is the current date. It can be changed to a future date upon selecting

If you select a future performance date, till its occurrence, the transfer will have status "Under processing".

Template

The application makes it possible to save a template, which may be used for facilitation upon subsequent payments to a counterparty. In order to use a template it is necessary to go to the "Templates" menu.

After completing all the necessary fields, the transfer is created with the "Next" button.

The next screen displays the details of the entered transfer, including the amount of the transfer, the transfer fee and the total amount with which the account of the ordering customer will be debited.

For transfers between accounts in different currencies, there is a possibility to negotiate an FX rate, by selecting the field **"Negotiating of exchange rate".** The system sends a push notification with the approved by the Bank negotiated rate.

The following possibilities for the transfer are possible:

- Confirm with the selection of this button and entry of PIN or via using Face ID / Touch ID (Fingerprint) the transfer is signed by the user electronically and is accepted for processing at the Bank.
- **For later** the transfer can be accessed in the menu "Waiting for confirmation", from where it can be confirmed.
- **Cancel** selected upon refusal of the transfer.

4.1. Transfer within the Bank

The menu provides the possibility for ordering transfers to own accounts at the Bank, as well as on accounts of other clients at the Bank. In order to create a payment order on the account with CCB Plc, it is necessary to enter the following components:




6.2 Transactions

Upon selecting the button "Transactions", a window appears, in which it is necessary to enter the desired period, for which a report has to be made for the performed transactions.

CCB Mobile gives information of the performed transactions with the card type payment of goods and services at traders and cash withdrawal. The system gives information of the following parameters of each transaction performed with the card:

- 5.2.1 Transaction type (Purchase/Cash withdrawal) and hour of performance;
- 5.2.2 Date date on which the transaction was performed;
- 5.2.3 Amount amount in the currency of the transaction;
- 5.2.4 Equivalent amount shows the equivalent amount in the currency of the card /account;
- 5.2.5 Fee shows the fee collected by the Bank for processing the respective transaction.



6.3 Block

Via button "Block" you can restrict the cards registered in your profile. For this purpose it is necessary in advance to activate this option at an office of the Bank or via CCB Online with QES from the SETTINGS menu – Changes in the registration/Limits by ticking the field "Blocking is allowed". After successful performance of the action, the card status in the mobile application will change to "Blocked".



 - Monthly installment;
 - Amount for full repayment payable till dd.mm.yy;
- * The amount of the exceeded limit is visualized in the field for credit product overdraft.
 - Select the liability, which will be repaid;

14.2 Change of PIN

The user of the mobile banking can change the PIN at any time.

- Upon selecting the option "Change of PIN", it is necessary to enter the present /current PIN;
- On the next screen it is necessary to enter the new PIN



- For the purpose of security it is not allowed to enter PIN, consisting of equal digits. A message appears "Warning. The PIN is rather easy".


